

# SCARECROWS in the PARK - 2022

## Guideline & Registration Form

### Plymouth Community Chamber of Commerce



We are excited that our 100 Scarecrows will visit Plymouth's Kellogg Park again this year!! Members of the Chamber of Commerce, non-profit organizations and community residents will have the opportunity to enter a drawing for a Scarecrow space, pole and bale of straw in the Park. We will have two separate Scarecrow drawings, one for Members of the Chamber and one for community groups and residents. We will begin taking registration forms (located at the bottom of this sheet) starting on **Monday, August 1st** and will hold the Scarecrow drawings on **Wednesday, August 31st**.

Decorating your Scarecrow is left to your imagination, creativity and ingenuity; however, the following includes some guidelines we encourage you follow when planning your Scarecrow:

1. **Decorations may be purchased or made. Decorations made of cardboard or paper are discouraged unless protected by plastic spray or lamination.**
2. **We ask that decorations designed to feed wildlife not be used.**
3. **Decorations should be tied or wired securely to your Scarecrow to resist high winds and vandalism.**
4. **Items especially attractive to theft should not be used. For example, beverage containers that carry a deposit.**
5. **Your company name/group name will be on the sign we provide. No promotional handouts, business cards or other loose items for the public to take are permitted.**
6. **The Plymouth Community Chamber of Commerce reserves the right to remove any item on or about the Scarecrow, or the entire Scarecrow if it is deemed by our discretion to be inappropriate.**

Cost: **\$70** for Chamber members, community groups and residents; and **\$60** for non-profit organizations (this cost includes proper environmental disposal fees). Payments are to **be made within one week of notification**. To register, you must complete this form which can be emailed to [mary@plymouthmich.org](mailto:mary@plymouthmich.org), faxed to (734) 404-6026 or brought to the Chamber at 850 W. Ann Arbor Trail. We will notify all applicants as to whether or not your application was chosen for a Scarecrow.

Winning participants may decorate their Scarecrows beginning **Friday, September 16<sup>th</sup>**. Decorating must be completed **by Friday, September 23<sup>rd</sup>**. Please let us know if you cannot have your Scarecrow completed by that date.
