  - The full seasonal rate (\$345) by April 11, 2022
- \$450 for a Gathering Stall (12 ft. X 12 ft.) \_\_\_\_\_
  - One half of the total rate of fee must be paid by April 11, 2022 and the balance must be paid by June 20, 2022 – NO EXCEPTIONS.
  - Gathering stalls are reserved for 2021 vendors.
  - A waiting list will be started for any open spaces that may arise.

  - Weekly booths are available on a first come first serve basis.
  - Application must be already approved and on file before arrival at the market.
